We working on raising awareness of two main issues this year: traffic safety and destigmatizing mental illness. We raised awareness of traffic safety by airing weekly information sessions during morning drive. Destigmatizing mental illness was addressed through our bi-monthly podcast "Coping 101".

One of their communication officers participated in weekly interviews that were aired in segments during morning drive one day each week. For the Coping 101 podcast series, we partnered with Seattle Childrens' Hospital, TeenLink, 4Culture, and The Seattle Times.
